

MAC Life Groups Child Care Disclaimer

This notice and disclaimer is to inform the Parent(s) or Guardian(s) (heretofore referred below as “you” or “your”) participating in a Missoula Alliance Church (heretofore referred below as “MAC”) Life Group of the child care provision or referral situation with regards to Child Care Provider(s) (heretofore referred below as “his”, “her”, “them” or “their”.) The purpose of the MAC Life Group child care referral list (which may be provided upon request) is simply a list of potential child care providers for you to investigate and use as you see fit during a MAC Life Group meeting. All parties are hereto notified and agree to the following notices contained herein, including but not limited to:

- MAC has not investigated nor will investigate in any way the quality of the service(s) provided by the Child Care Provider(s) or their fitness to provide child care services, and does not supervise them in any way.
- MAC makes no representations about the character, quality or calibre of the person(s) providing child care and cannot, therefore, endorse or recommend their services.
- MAC is unable to provide you with a caregiver at this time which has been investigated, interviewed, “vetted”, trained or validated in any way. Therefore the referral list of potential child care providers is **not** monitored, approved or used regularly by MAC for Child Care Services.
- MAC does offer a subsidy to help ease the financial burden to MAC Life Groups with regards to child care. Receipts for the total cost verifying the date and time of care provided, caregiver’s full name, age, address and contact number along with the name of the MAC Life Group, and the name of the Leader(s) are required in order for MAC to provide any subsidy assistance. Assistance is not guaranteed nor a conveyance of approval of Child Care Provider(s).
- MAC recommends that you ask potential child care providers for references, a Child Intervention Record Check and a Police Information/Background Check (if legal) for those working with Vulnerable Persons.
- **Notice** : Montana does not govern a minimum age which someone must be in order to start babysitting. As a guideline Mac recommends that individuals be 13yo or older however **the final decision regarding the care of your child or children is your responsibility.**

Waiver of Liability, Release, Assumption of Risk & Indemnity Agreement Notice: The Parent(s)/Guardian(s) understand and furthermore agree by participating in a MAC Life Group and utilizing the provided/referred child care services that you are agreeing to this Childcare Waiver of Liability, & release and furthermore hold harmless MAC, and its Pastoral Staff, Elders, Life Group Leaders, directors, officers, advisors, employees, agents, instructors, volunteers, childcare workers, and all other persons or entities acting for them from any and all claims, demands, suits, cost and charges, in connection with or arising out of MAC Life Group child care referral, including but not limited to, personal injury, bodily harm, injury, or property damage occurring while your child/children is/are in the care, custody, control of provided / referred Child Care Provider(s) at a MAC Life Group meeting.
